2025 Scholarship Highlights



- 23 students received financial support for the 2025 scholarship year, totaling \$41,000.
 - RPWP Scholarships - \$16,000 (8 students)
 - Book Stipends- \$4000 (8 students)
 - Heritage Scholarships - \$21,000 (7 students)
- Received 67 Scholarship applications
 - 20 for RPWP scholarships (4 not eligible)
 - 46 for Heritage scholarships
- A total of 38 guests attended the scholarship awards reception, including parents and members



2025 Program Highlights

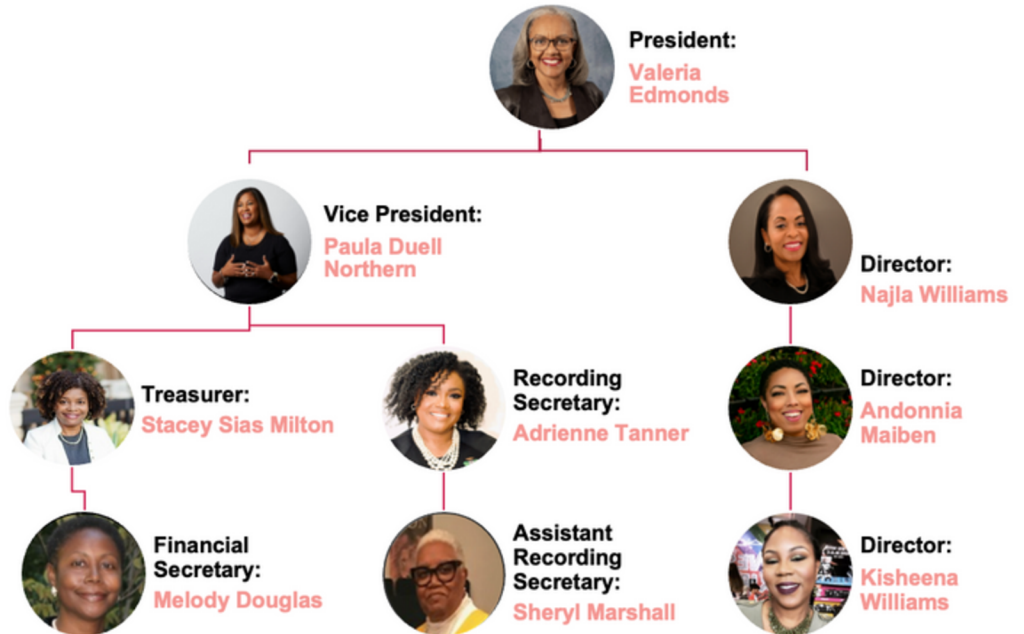
